

# **Lifetime Limited Warranty**

The following Inteplast® brand products manufactured by INTEPLAST GROUP CORPORATION (IPC), Inteplast® PVC Deck, Inteplast® PVC Dock, Inteplast® PVC Porch, Inteplast® PVC Trim, Inteplast® PVC Siding and PVC Moulding (excluding Prefinished Moulding and non-white, colored Beadboard\*), are backed by a lifetime limited warranty for single-family residential purchases and applications. For all other purchases and applications, including commercial use, condominiums and multi-family dwellings, this warranty shall be limited to a period of twenty (20) years. The warranty is limited to the lifetime of the original purchaser for as long as he/she owns the property on which the product is applied and shall not be transferable. If, due solely to manufacturing or material defects, the product is found during this warranty period to rot, delaminate, splinter, crack, split, excessively swell, or suffer structural damage from termites or fungal decay, IPC will, at its sole and absolute discretion, provide replacement product, repair the defective product, or refund a proportional part of the purchase price prorated over 30 years on residential purchases (20 years on commercial and non-residential purchases). In no instance will the cost of the remedy to IPC exceed the original purchase price of the affected product.

#### Claims

In order to file a valid warranty claim, and before IPC's obligation under this warranty shall commence, the original purchaser must send proof of purchase, photographs of the defective Inteplast<sup>®</sup> product, and a written description giving full particulars within 30 days of discovering a defect believed to be covered by this warranty (and prior to beginning a repair or alteration) to:

IPC reserves the right to investigate any claim arising under this warranty. As such,original purchaser shall make available for inspection by IPC or an appointed representative, the product believed to be defective.

#### **Exclusions**

The warranty is limited to the foregoing and shall NOT apply to: (1) product which was not installed in accordance with IPC's installation guidelines or installed in a less than workmanlike manner; (2) product which has been structurally altered or damaged by fire, flood, lightning, windstorm, hurricane, earthquakes, tornado or other acts of God; (3) product which has been installed or applied to a function or use other than the ordinary purposes for which it was intended; (4) natural effects under normal weathering of the surface (including fading, peeling or discoloring due to exposure to sunlight or weather conditions); (5) cost of labor, materials or the expenses incidental to the repair, removal, installation or replacement of the warranted product; (6) product which has not been properly stored or handled; (7) product which has been damaged during shipment, storage, handling, or installation; or (8) any applications of painting or coating to the Product.

#### Limited Warranty Non-White Colored Beadboard

With respect to the non-white color Beadboard, IPC warrants in connection with single-family residential purchases and applications, that the film laminate component of the non-white colored Beadboard will not discolor beyond the following manufacturer's tolerances for 12 years from the date of original purchase, provided that the product is not used under conditions where it is exposed to direct sunlight.

#### **Prorated Warranty Schedule**

Further, IPC warrants that the application of the non-white colored film onto the underlying PVC substrate to be free from manufacturing defects for 12 years from the date of original purchase.

#### Warranty Amendment

This lifetime limited warranty shall not be altered or amended except by a written instrument signed by IPC and the Inteplast<sup>®</sup> purchaser. No Inteplast<sup>®</sup> dealer or other person or entity is authorized by IPC to make statements about Inteplast<sup>®</sup> products except those included in this warranty. Inteplast<sup>®</sup> shall not be liable for statements made by a third party in contravention or in addition to this warranty.

#### Warranty Area Coverage

This warranty shall only be applicable and enforceable in the United States of America and Canada.
